## PARENTAL CONTRIBUTION 2019/2020 TO THE MAINTENANCE OF THE SCHOOL BUILDINGS

In voluntary-aided schools, such as St Mary's and St John's CE School, the Governors are responsible for the maintenance of the school buildings. Part of your responsibility in choosing a Church of England school for your child's education, includes an annual parental contribution. The Governors ask you to take this responsibility seriously.

Money raised by the Governors through parental contributions is administered by the London Diocesan Board for Schools ("LDBS"), who carry out necessary work on the school buildings. **Every ten pounds raised from parental contributions can unlock up to a further ninety pounds from the LDBS pool of funds. Further funds can be received from the "taxman" through the government's Gift Aid scheme. These significantly multiply the impact of your contribution and the benefits to your children's education.**

**In the 2018/19 academic year, this money was used to install security screening on the back boundary of Bennett House Campus, additional fencing at Neale House and phase 1 of roof repairs again at Neale House campus, which will be completed shortly.**

**The recommended parental contribution this year (2019/20) is £40 if you have one child at the school (£25 for a Nursery child), £65 for 2 children or more. (Contact the office if you would prefer to pay in termly installments)**

Please complete the attached standing order and gift aid forms and return them to the school office. Alternatively, you can enclose a cheque, payable to "St. Mary's and St. John's CE Governors Account"

Parents with children already at the School will be able to pay online via ParentPay.

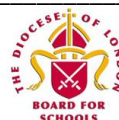
